

General Guideline for those people who are quoted as witnesses:

It is prohibited to entry into the courthouse – except if it's necessary to the conduction of a procedural action – with gun, cartridge, explosive, blasting agent and with especially dangerous tool for the public safety or with a proper instrument for affray – except of the professional attached staff of the police, penitentiary college or other armed forces. The security service is entitled to monitor this, they provide their job through security technology equipments (person cheking gate, manual metalfinder detector and x-ray package inspector) used in the court.

Testifying is an allegiance which involves the obligation of appearing in front of the court according to the judicial writ. In case of when the witness can not appear in the hearing, he or she must give a notification in advance, in written – referring to the number of the case – about his or her non-appearance at trial court, at the same time must attach a certification supporting the substantial cause of his or her non-appearance as well.

The witness has to bring with him- or herself his or her writ, identity and address card. It is possible to wait in front of the courtroom on the corridor where seatings are available. There is opportunity for closed management of the personal datas of the witness – for his or her request –.

In the courtroom it is required to appear in sufficant clothes which suit to the honor of the process, and the behavior has to be orientated the same way. During the time being in the courtroom, being bare-headed is obligatory. The trial is guided by the judge, everybody has to observe the orders of the judge. Asking from the witness, recording picture or sound of the witness can be only with the permission of the chief judge.

Frequently Asked Questions (FAQ) on the field of Witness' Care

Accessibility by car

GPS: X 20,15 Y 46,254

Downtown of Szeged can be reached from 4 different Main Roads, and from the Motorway M5 and M43 as well.

The arrivals from Motorway M5 and Main Road 5 (Budapest) can get to downtown of Szeged through the Dorozsmai út (Road). The building of Szeged Regional Court and Szeged District Court can be reached straight on the line of Dorozsmai út (Road) - Kossuth Lajos sugárút (Avenue) – Széchenyi tér (Square).

The arrivals from Main Road 5 (Röszke) can reach the building under Number 4 Széchenyi tér (Square) as turning left at Main Road 5 – Kálvária sugárút (Avenue) – Dugonics tér (Square), turning right at the crossing of Tisza Lajos körút (Ring Road) - Kossuth Lajos sugárút (Avenue).

The arrivals from Main Road 47 (Hódmezővásárhely) can approach the courthouse through the line of Main Road 47 – József Attila sugárút (Avenue) – Tisza Lajos körút (Ring Road) – Takaréktár utca (Street) – Széchenyi tér (Square).

The arrivals from Motorway M43 (Makó) get to the courthouse deviating to Main Road 47 on the line as detailed earlier.

The arrivals from Main Road 43 (Makó) can approach the courthouse on the Széchenyi tér (Square) as turning left at the crossing of Main Road 43 – Székely sor (Street) in the direction of Downtown Bridge – Híd utca (Street) going straight forward.

The courthouse under Number 4 Széchenyi tér (Square) can be reached as turning left at the roundabout of Main Road 55 (Bajai út (Road)) – Kálvária sugárút (Avenue) – Dugonics tér (Square), turning right at Tisza Lajos körút (Ring Road) – Kossuth Lajos sugárút (Avenue) by the arrivals from the Main Road 55 (Mórahalom).

Parking

The arrivals by car can find parking lots in front of the building of the court or behind the building in Deák Ferenc utca (Street) and next to the building in Wesselényi utca (Street). Parking in Szeged is subjected to fees, it is possible only with in advance released and validated parkingticket. Parkingticket must be released in advance, is available at newsagents in Széchenyi tér (Square) or by mobilephone in SMS through the system of SZEPARK Corporation hereinafter: <http://www.szepark.hu> as well.

Accessibility by public transportation

Arriving to Szeged by train:

The railwaystation can be found under Number 20 Indoház tér (Square), Szeged.

By walk: the courthouse can be reached in 15-20 minutes from the railwaystation through the line Boldogasszony sugárút (Avenue) – Square of Aradi vértanúk – Kelemen utca (Street) –Széchenyi tér (Square), which is guiding into downtown.

By public transport vehicle: from the railwaystation the station of Széchenyi tér (Square) can be approached in 10 minutes by tram Number 1, where the courthouse is in 2 minutes by walk. (Tickets are available for purchase on the tram as well.)

If you are arriving by bus to Szeged:

The bus terminal can be found on the Mars tér (Square).

By walk: the buliding of the court is reachable in 10-15 minutes from the bus terminal trough the Mérey utca (Street) – Kiss Ernő utca (Street) – Széchenyi tér (Square) line, which is guiding into downtown.

By public transport vehicle: the courthouse is approachable in 5 minutes from the bus terminal starting in front of the Anatomy Institute under Number 40 Kossuth Lajos sugárút (Avenue) by tram Number 1; from the Mars tér (Square) into the Széchenyi tér (Square) by trolley bus Number 5, 7, 8, 9, 19; or by local busses Number 60, 60Y, 70, 71, 72. (Tickets are available for purchase on the public vehicle as well.)
